9. Grant applications

Posters, inviting applications were placed in the Parish Notice Boards and posted on the What's on in Grundisburgh News Group on the 9th October asking that village organisations that wish to apply for a grant should do so by 3rd January, 2019. The Committee should anticipate more requests being received by that date.

Applications Received

Mr. Paul Wiffen - Project: "Chap's Chat" applies for a grant towards purchasing a device that allows people with a hearing difficulty to hear when chatting in groups. The device is a 'multi-directional microphone' [called a 'pen'] and base holder, plus a fob worn around the neck of each hearing impaired person. The base with pen is £500 + VAT and the fobs are £116 each + VAT This project has been running for 10 months and now has 6 members all in their 80s plus. It gives contact and conversation to isolated men in the village. It meets most Friday mornings at Mrs Williams for one and a half hours. This has been a great success and hopefully will grow. This application was forwarded to the Finance Sub Committee on the 11th October.

It was agreed that the Clerk should write to Mr.Wiffen informing him that grant applications should be submitted by village voluntary organisations and that the council usually donated a proportion of the cost of proposals.

The charge for each other bands is calculated by multiplying the Band D charge by the appropriate scaling factor i.e. Band A - 6/9 B 7/9 C 8/9 E 11/9 F 13/9 G 15/9 H 18/9

Before CTSG it had been the Parish Council's policy that it would be wise to annually increase the precept by small amounts to maintain the council's finances and to avoid the necessity of a substantial increase sometime in the future. It was therefore agreed that the committee recommend that the Parish Council should apply for a precept of £19,000. With the increased number of Band D equivalents in 2019/2020 Band D council tax payers will see an annual reduction of 10p the Parish Council charge.
